Sailor learns hard way: Swimmer can't catch sub

GROTON, Conn. (AP) - Renato Mendoza, 22, a sailor, nearly drowned Sunday when he tried swimming to his submarine as it moved down the Thames River out to sea.

Police said Mendoza, anxious to avoid an AWOL mark on his record, jumped into the water to intercept the submarine Piper.

He became exhausted a quarter mile out and shouted for help. A police launch was called out, but he made it to shore by himself.

Police said Mendoza had been on leave in Philadelphia and returned to New London Sunday as the Piper pulled out to sea without him.

Mendoza is helping out at the submarine base until the Piper returns in a week.


Claims Dive Record

USS PIPER—This flotilla submarine, homeported at New London, Conn., claims she leads the active subs in the Atlantic and Pacific fleets in total number of dives. She has made 13,120 dives as of late August.

The highest number recorded in the Submarine Library of the Naval Submarine Base, New London, is 13,851, by the submarine Sarda at the time of her decommissioning in 1964.

The record came to light when her skipper, Lt. Comdr. R. A. Preble Jr. ordered a special celebration on the occasion of her "Lucky 13 Grander." She broke the surface for the 13,000th time on the return leg of a Submarine School training cruise to Bermuda.

All diving stations for the "Lucky 13 Grander" were manned by crew members with more than three years aboard. Conning officer was commissaryman First J. C. Burke, who has served aboard since July 1958. Burke was assisted by Quartermaster Second A. A. Cross, diving officer.


Decommissioning Of Sub Set Friday


PORTSMOUTH (AP) - The submarine Piper will be decommissioned Friday at the Norfolk Naval Shipyard and her crew will depart for new assignments.

The Piper will be sent to Detroit, Mich., where she will be used to train naval reserve personnel.

Commissioned here in 1944, the Piper has compiled a record of 13,724 dives, more than other active submarines in the fleet.

In June 1967, after many years of fleet operations, and after more than 13,000 dives, Piper was decommissioned at Norfolk, VA and assigned as a Naval Reserve Training Submarine arriving at Detroit, Michigan in July 1967. She is moored at Brodhead Naval Armory Dock, 7600 E. Jefferson Ave.

2 Seek to Save Sub

After 125,000 visitors in the past four years, the submarine Piper is scheduled to be scuttled and sold by the U. S. Navy unless the city of Detroit comes to her rescue.

The 311-foot long sub, moored since 1966 at the Brodhead Naval Armory near the Belle Isle Bridge, was closed to the public last month as a money-saving effort by the Navy.

She and a sister submarine also moored at Brodhead are scheduled to be sold next month as scrap for about \$3 million each.

But two Common Council members hope they can arrange to preserve Piper as a dry-dock memorial.

Carl Levin and David Eberhard are expected to plead their case in Tuesday morning's council meeting. Sources in the Department of Parks and Recreation, which would have to care for the memorial, say department officials have so far discouraged the idea.

The Piper's sister sub, the Cero, was

retired from the Navy in 1958 and officially "killed" in 1967. Efforts since then to auction it have been unsuccessful.

The 1,650-ton Piper was retired in August 1966. The two subs have floated side-by-side, moored to dock with steel cables. The Cero was stripped down in 1967; the Piper is now being dismantled.

Up until mid-June the Piper was open to tours by anyone interested in seeing the vintage diesel-engine craft. More than 125,000 people toured its cramped quarters in the four years it was on exhibit.

That was more attention than the Piper got when it was active. Commissioned in 1944, as one of the last 100 subs built specifically for the Pacific Theater, the Piper never engaged the enemy in its patrols.

Later it was outfitted with sonar equipment as a submarine-hunter but never got to use its fancy equipment in war.

IN RETIREMENT the Piper was

used by the Naval Reserve Training Center to give first-hand instructions to young reservists.

The Piper and Cero each cost about \$4 million when they were mass-produced. Today, when nuclear-powered subs cost \$100-plus million, the Piper and Cero are worth \$3 million each in scrap metal.

In their prime each sub commanded a crew of 80 and an officer team of seven. Even in retirement the Piper had a seven member crew and a captain to handle the tours and maintain equipment.

The utility bill alone for the Piper—lights—and ventilation—runs about \$11,000 a year.

Lieutenant A.E. Smith, the last commander of the Piper, said the subs can only be sold to salvage firms or as memorials.

"The sentimental value of the men who have served on a sub prevents us from selling it to someone who would turn it into a restaurant, for instance," Smith said.



William Albert Huston - LT USN USS Piper SS-409



Feb. 4, 1940 - Sept. 15, 1964

While serving as the "1st LT" aboard the submarine USS Piper SS-409, LT HUSTON was lost at sea on 15 September 1964 in the Mid- Atlantic Ocean.

LT HUSTON and several enlisted men were sent on deck in heavy seas to sever a loose mooring line that was trailing behind the submarine and was in danger of fouling the propellers.

After severing the mooring line, the men were attempting entry into the superstructure when one enlisted man was washed off of his feet by waves. LT HUSTON was able to pull the man to safety, but then he was struck by a wave and washed overboard when his safety line became undone.

The lookouts maintained sight of the man while the submarine maneuvered into a position where a line could be thrown to him. On the second try, the thrown line landed very close but the man made no attempt to grasp it. The effects of the cold water had probably disoriented and weakened him by that time. Despite losing visual contact with the man the searching continued for several more hours, but they were unable to recover LT HUSTON.

Wallace W. Hankins Jr., CAPT, USN, Ret., died September 24 from complications of heart and pulmonary disease at his home in Annapolis, surrounded by his family. He was born in Minnesota to Wallace W. Hankins Sr. and Beatrice Hankins. He was raised in Duluth, where he at-



Hank was born to the late Joseph and Marian Wiley on January 4, 1943 in San Bernardino, CA. He attended many grade schools while his father


